1. Prevents the emergence of crabgrass seedlings without harming the desirable turfgrasses listed below.
2. Prevents seedlings of Foxtail and Barnyardgrass from emerging.
3. Permits seeding of your lawn while controlling crabgrass at the same time.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production or for research purposes.

1. For use on newly-seeded or established plantings of the following grasses:

DO NOT USE on other Bentgrass strains or Bermudagrass

2. Rake lawn to remove leaves and other debris.
3. **On Established Lawns** – apply at the rate of 4 lbs. per 1,000 sq. ft. (20 lb. bag covers 5,000 sq. ft.). Apply after the 1st or 2nd mowing (usually at the time forsythia blossoms start to fall) in the Spring before crabgrass and other annual grass weeds emerge.

4. **On Newly Seeded Areas** – apply at the rate of 2 lbs. per 1,000 sq. ft. (20 lb. bag covers 10,000 sq. ft.). Apply immediately after seeding in early Spring before crabgrass and other annual weeds emerge.
5. Apply with a fertilizer spreader (see settings below) to insure even coverage.
6. If it does not rain for three days after application, water the treated area thoroughly to get desired results. Timing application just ahead of a predicted rain is ideal.
7. A second application one month later will help control late-germinating crabgrass.
